2. Special presentation: Laura Morin came to provide information and answer questions regarding coyotes found in Maidu park. Ms. Morin stated that the coyotes have become somewhat brazen of late. People have been walking dogs off leashes which makes them the small dogs a target for the coyotes. They also pick cats up off the street. With the area are also found cougars, mountain lions, and recently even bears. The wild animals in the area travel along the creeks. Ms. Morin stated that the primary issue is one of coexistence between residents and animals. This requires taking some basic steps.

Keep dogs on leashes. The long reel leashes don't protect smaller animals. Don't feed the wildlife! Keep cats inside. Pet food needs to be removed at night. Food can't be left outside. Food attracts not just the larger animals, but rats, raccoons, and skunks as well.

Concerns were repressed regarding the necessity of putting these animals down when they become too much of a problem rather than other alternatives. Ms. Morin explained why they can't be relocated. The problems are a combination of cost, and the fact relocated animals have almost 100% fatality. Relocation is simply moving our problem on to some other community. When animals become too aggressive they have to be removed. This is true from cougars as well as coyotes.

Mary also asked about dog pick up problems. She had some dogs loose in her yard. When she contacted Animal Control she found they couldn't do a pick up because they were closed. Ms. Morin informed us that these animals can be taken to the SPCA as an option.


8. Old Business:
