2. Sign in/Welcome

3. Minutes of previous meeting: Approved.

4. Police Report: Marc Kelley joined us this evening. We discussed the issue of Video Surveillance. Officer Kelley suggested it is probably more preventative than helpful. If cameras are placed so they maybe observed from the sidewalk but too high to damage they can be helpful. After a break-in unless they are very high quality they may or may not be helpful in identifying an individual.

We had a short discussion regarding the possibility of obtaining a system to lend out as needed but have decided against doing so at this time. This was due in part to Lance's comment. He was aware of a test which showed the camera was not adequate for identification purposes. This was supported by Officer Kelley's comments.

Lance asked about the city placing cameras at the entrance to certain areas within the community. In some communities, i.e. San Francisco, businesses defray the cost. The city of Roseville hasn't shown interest in putting out the money.

5. Treasurer's report: The beginning January balance was \$2,055.58. The ending January balance. \$2,055.58

6. RCONA report:

a. Catalytic Converter Thefts: Roseville Toyota, McNally Napa Auto, and Firestone on Washington Blvd., are all painting and putting license numbers on catalytic converters.

- 7. Library Report: Fran didn't have a report because most of her involvement over the last couple of months has been with the cabinet work.


Ken noted there have been a few glitches in the computer conversion, which is to be expected. Some individuals with older library cards had problems signing on. This has been generally corrected.

They are in the engineering stages and looking at routing. They are dealing with "tricky" engineering problems. Meadow Oaks strongly asked that the paved trail not be put where their existing walking trails are being used. Mike Dour pointed out at the meeting that they are working to meet that goal. Nothing came up related to MNA.
