

**1. Elections of Officers:**

**Motion BM09/11-1:** Geoff moved that all individuals remain in the same positions currently held. Shirley seconded the motion. Approved.

**2. Open Board Position:** It was recommended that Ken Webb be appointed to Bonnie's unfilled term of one year. He would then be up for election next year.

**Motion BM09/11-2:** David A. moved that Ken be appointed to Bonnie's unfilled term. Jim seconded the motion. Approved.

**3. Special presentation:** Lisa Brown—The state Legislature is requiring cities meet water efficiency standards or lose funding. Governor Schwarzenegger required water districts cut water usage by 20% by 2020 or water rights could be lost. Roseville has already met the 20% goal, but when the economy improves usage is expected to go up.

The city has a number of programs. A lot of the programs focus on the outdoors leading to the Cash for Grass program. This is the biggest water saving program the city has. There are irrigation efficiency programs, water pressure reducers, efficient sprinkler heads, smart timers (adjusts timing due to humidity, weather, etc., as well as the layout of landscaping), pool cover, etc. In some cases there are rebates or in others, the city provides the product itself. There is a Water Wise House Call program available through the city. [www.roseville.ca.us/savewater](http://www.roseville.ca.us/savewater)

On the website is a place to anonymously report water waste. [www.roseville.ca.us/waterwaste](http://www.roseville.ca.us/waterwaste). Water waste is a violation of the municipal code.

Indoor programs include rebates for: high efficiency toilets, high efficiency clothes washers (front load), high efficiency shower heads, and aerators, etc. Moisture meters are available on a loan basis and hose nozzles are provided free.



  - c. Santa in the Park: We will address this issue next month when RCONA's plans have been clarified.



**Introduction:** The following reflects my audit for the period of September 2010 – August 2011.

**Audit Details:**

- a. Overall the Association carries on very little financial activity which makes it easy to analyze.
- b. For the year reviewed there were only ten transactions taking place in the Association account, kept in River City Bank. There are detailed as four (4) checks; six (6) deposits related to the Garage Sale.
- c. In July the account was transferred from River City Bank to US Bank. In that process River City issued a check for \$100 more than was in the account. This amount was returned.
- d. On the US Bank account for the period reviewed there for two (2) checks and no deposit.

e. Combined Activity:

My analysis agrees with activity in both check book and activity journal.

- a. Documentation was provided for all checks and deposits. Thank you.
- b. Last year I suggested it might be easier to keep the activity journal in Excel rather than by hand. I still think that might make the accounting easier. But because of the low level of activity the current approach works fine. Mary does an excellent job of keeping the books and therefore no change in methodology is warranted.
