2. Special presentation from Fire Station #4 – Fireworks safety. General comments were made. These included the importance of changing batteries in alert devices twice a year, and warnings against leaving candles and cooking unattended to prevent fire.

The Fire Department's website, <http://www.roseville.ca.us/fire/>, is a source for many safety tips, including leaving a key, lockbox, etc. somewhere so the department can get into a home without having to breakdown a door. Also have dogs locked up if possible.

The Vial of Life program was presented, <http://www.vialoflife.com/>. When emergency officers arrive at a home it is often hard to get accurate medical information from the victim or anxious family members. The Vial of Life program can provide this information which will allow them to get all the info they need. These forms are available at the Maidu Community Center, the Sutter Roseville Hospital, and Fire Stations.

Regarding fireworks, they can be fired from the 28th through the 4th. Anything that comes off the ground or shoots into the air is illegal. Fireworks are not to be modified in order to get more spectacular results. Block parties aren't technically legal though there shouldn't be a problem if they are spontaneous. Planned parties require a city permit. In any

case if a party is held, streets cannot be blocked of. There must be emergency vehicle access. Where there is concern over grass fire creating a need for weed abatement call the city non-emergency number, (916)774-5824. If you see smoke, call 911. On the 3rd and 4th the fire department will have a couple of extra vehicles out checking for problems.

A question came up regarding the expiration of fire extinguishers and their disposal. The response was, 10 years for ones purchased at hardware or big box stores, or when their dial shows there pressure is no longer in the green zone. Ones purchases elsewhere may have a shorter life. The city waste management division will pick up hazardous materials, in general and fire extinguishers specifically, if called. 3. Special presentation – 9-1-1 operations: (see attached) This was a presentation on the basic ways that 9-1-1 works. A landline it is the best confirmed location and so recommended. VoIP presents a problem because an internet connection will not show actual location of the connection but home location. Cell phones show up on the nearest tower which can be significantly different than the actual location. GPS can help but still generally not as accurate as the landline.

What is an emergency is somewhat subjective. If an individual is in pain and doesn't know what to do, or if they see someone suspicious call 9-1-1.

When calling to report a crime, the primary concern is the caller and the police safety. (1) **Where** is it occurring? (2) **What** is exactly going on? (3) **Who**, do you know who is doing it, or what is their description? The operator will ask questions to help answer the question. If a car is involved what make, model, color, and if possible, license number? (4) **When** did it occur? If it happened outside a short time window it is considered cold and the caller may be transferred to the non-emergency number. (5) Are there **Weapons** or injuries involved?

Medical emergencies: The operators are emergency response certified and so they ask very specific questions to help the fire department know what to expect. The average response time is 5 minutes and from the time the phone is picked up until help arrives averages 6 to 7 minutes. Roseville has one of the fastest response times around.

There is a “seven digit” emergency line (916) 786-6444 which will connect with a live operator.

Thanks to all for your support and suggestions they play a huge part in keeping our library open and used in so many meaningful ways.”


9. Old Business:
