3. Police Report:

- f. Update on Ridgecrest Speeding: Lieut. Walstad had officers run speed tests on the affected streets. They were out during the school times and most of the speeding was 30 miles plus. (They don't generally ticket for speeds of only 5 miles over speed limit.) The fire department will not allow speed bumps. One neighbor noted, as a Sacramento Fireman, that Sacramento does allow speed bumps there.

The Lieutenant noted that Stop Signs can be problematical. The primary solution is education in the neighborhood. Another solution is blocking Ridgecrest but this probably wouldn't get passed the Traffic Commission.

This area has been an ongoing problem over many years (17-20 plus). There were a number of questions and discussion. One suggestion was a "speed-trap" camera. Lieut. Walstad will explore this as well as other possible solutions.

The Lieutenant will return next month to give and update. We will publicize this and depending on what he reports the board will be open to setting up a task force to pursue the problem.

A concern was brought up requesting a traffic patrol on Champion Oaks in the morning because of serious speeding.
