2. Sign in/Welcome

3. Police Report:

- a. There has been a significant increase in “door kickers.” Officer Stokes’ assumption is that these individuals are casing neighborhoods. It is unclear if they are watching specific houses or the neighborhood in general. It appears these break-ins are only if the perception is the house is unoccupied. The break-ins can happen any time during a day. Where someone has been present, the offender(s) flee. Drugs seem to be an underlying motivation.
- b. There were also a number of car break-ins. Officer Stokes’ recommendation was that everyone should leave their “porch lights” on all night.
- c. There was a burglary on Chippendale. It was a break-in where electronics and a car were stolen. This occurred sometime between June 11th and 12th. Lieutenant Walstad reported on a number of other car break-ins.
- d. There was a general discussion of things to watch out for to help make the neighborhood a safer place. This was a reminder for the board that we need to address these issues on a regular basis in the newsletter.
- e. There was a short discussion of the “early release” program, which does impact Roseville. Generally these individuals don’t have to register in the community with a few exceptions, i.e. sex offenders and some drug crimes. (AB109 is the underlying legislation that created the problem.)


4. Minutes of previous meeting: Approved

5. Treasurer's report: The corrected beginning July balance is \$2,264.10. The ending July balance is \$2,264.10.
6. RCONA report:
 - a. Jim presented a copy of the new boundaries for the neighborhood associations. This was approved by RCONA. The new maps will be approved by the city and police and probably issued in about 60 days. (see attached).
 - b. August 24th is the Town Square grand opening.
 - c. Parks and Recreation received a grant for a game package for National Night Out. Jim picked up the package for us.
 - d. The July 30th Downtown Tuesday night is again our responsibility. Jim is looking for additional volunteers. Kyoungah volunteered.
 - e. This Saturday, the fourth movie in the Park, is at Royer and is Brave.
 - f. On July 3rd Jim represented us at the monthly meeting, thanking the Fire Department and Police for their efforts handling the Maidu Park fire. He also thanked the Mayor who called him at the time of the fire to ask if she could help. She did obtain the Community Center for our fire related meeting last month.
 - g. RCONA pays the first \$100 in any expenses incurred for the National Night Out
 - h. Jim asked if we wanted the "free" case of the "Keep Kids Alive" signs. We had already approved by email.
7. Library Report: (see attached)
 - a. The city had a resolution congratulating the Friends of the Roseville Library who have been around 40 years and have donated over \$300,000. (see attached)
 - b. The Library and Museum will be closed on August 9th.
 - c. There will be a new "bookmobile" which will go to underserved areas and shuffle requested books between branches. The library system has \$50,000 towards the vehicle and needs help to raise another \$50,000. The intent is to have it up and running by Spring 2014.
 - d. The library has loaded Chrome Books available for borrowing.
8. Old Business:
 - a. National Night Out update: We need to contact Lance to see where we stand in the preparation process. The time set for the event is 6:00 to 8:30 PM. Consequently, the set up time is 5:30. David, Jim, Vicki, and Kyoungah will be there to help. Scott and Geoff are tentative. Scott will contact Lance to follow up with him and cc David and Jim. Jim will contact Shirley regarding her participation.
9. New Business:
 - a. Cloud Storage. We can use Google Drive to create a site where documents can be passed between board members. Scott will move forward and do some testing before we have a vote on approving this tool.

10. Announcements and Remarks:

- a. David reinforced Geoff's idea of having a monthly crime tip on the newsletter.
- b. It was suggested that we provide a crime quiz with small prizes using some of the funds we have. The intent is to spark more interest in citizen participation in creating in environment concerned with protecting our community. David will put something together.
- c. Ken noted that last year he participated in the Roseville Police Academy and highly recommends it as a really great experience.

Residential burglary: Overnight June 11/12, a home in the 1000 block of Chippendale Way was broken into while residents were away, electronics were taken from the house, and a green 1998 Subaru station wagon was stolen from the garage (since located outside of Roseville). A suspicious person was seen in the area, an unshaven white male, 28-30, short black hair, driving an older black Honda Civic. (13-6113)

Vehicle burglary: Between 9:30 and 10:40 p.m. June 20, someone smashed the window of a car parked at Maidu Park near the softball field, and took cash and a cell phone.

Maidu Fire on 6/21/13: Still under investigation. A juvenile was arrested for setting another fire in the South Cirby area. The connection, if any, is still being investigated. Investigators believe a group of juveniles was involved in starting the Maidu Fire. (Det. Zeri's investigation)

Vehicle burglary: Overnight June 24/25, someone got into a locked vehicle in the 3500 block of Annabelle by unknown means, and took a portable GPS and various (electronics?) cables.

Commercial burglary: In the early morning hours of July 3, a dentist's office in the 2000 block of Douglas was burglarized (back door found unlocked) and a camera was stolen.

School vandalism: At about 7:30 p.m. July 13, a good neighbor reported a group trespassing at Sargeant Elementary School. A group of males was seen using bolt cutters to cut a lock, and then going into the locked area to skateboard. Officers responded and arrested four males between the ages of 18 and 26, from Sac, Folsom and Stockton, for trespassing on school grounds and vandalism (damaging the school's gate).

Vehicle burglary: Overnight July 17/18, someone smashed the window of a car parked in the 2300 block of Thistledown and took a wallet and laptop computer. The suspects then used the victim's credit cards to make purchases.

Vehicle burglary: Sometime before July 22, someone broke into a car in the 1900 block of Hackamore Drive. (report not in yet, no further info)

General: Getting a few middle-of-the-night door kicks in the South Cirby and Cirby Ranch areas—once the burglars realize someone is home, they take off.
