3. Police Report:

- a. A question was asked regarding homeless issues. Officer Williams stated he isn't aware of any significant issue. But in any case the city is limited in what it can do. This is the result of the Supreme Court pretty much pulling the teeth of law enforcement by defining "camping" on public property as being within a domicile whether the individual is in a tent or sleeping bag. Accordingly so the police can't take action, including waking the person, without a warrant.
- b. Geoff asked about the effectiveness of curb numbers in assisting either the police or fire department. Officer Williams noted that both have access to both street and satellite views of homes and therefore curb numbers have become pretty much superfluous.
- c. As noted by previous reports theft activity goes up in the summer. There were two cars found with bodies in the trunk with a total of six body calls in the last few weeks. These included natural deaths as well as those needing investigation. There was one suicide on the west side. (Our own beat remains fairly quiet.)
- d. Prop 47 reduced almost all drug possession charges to misdemeanor rather than felonies. So there is no teeth in enforcement. Heroin has made a massive comeback due to this. This has led to deaths from dirty Heroin.

7. RCONA: None


8. Old Business:
