2. Sign in/Welcome

3. Police Report:

- a. The primary issue has been accidents over the last couple of nights.
- b. The same kind of theft that has always been going on continues. Theft of convenience.
- c. There have been an increased number of transients over the last 3 to 4 years due to legislative changes.
- d. Staffing changes have made response time longer except in true emergencies. A triage approach has needed to be taken. Other factors for slower response time has include reduced penalties putting more individuals on the street, changes in how to respond to the homeless, etc.

- c. Park Clean Up Results: Went well. About the same turnout as usual. Everyone seemed to enjoy themselves and we gave out the three gift cards from Target.
- d. Lighthouse Printing vs. UPS Printing: The Requests for Proposal were submitted. We are waiting for responses.
- e. Nextdoor Survey: Scott will check out Nextdoor and Geoff will check out Survey Monkey which would be used to put the survey on Facebook. The issue of survey questions will be handled via email.
- f. Santa in the Park: Mahany Park, December 9^{th} , 1:00 4:30 PM.
- g. Santa in the Neighborhood, December 5th. Volunteers should arrive at 5:30 to set up, the public at 6:00 and Santa will come around 6:30.
 - i. Jim will get the cups, cookies, cider and hot chocolate from Sam's. He also has the luminaries and candles so he'll let us know how many he has.
 - ii. Shirley has the tables. Someone will have to pick them up.
 - iii. As of now Vicki, Mary, Jim, Shirley and Scott will help.

8. New Business:

- a. Thank You Dinner for Block Captains: Discussed the over all approach and the need to have an invitation and a RSVP. The RSVP will ask for a yes or now and allow for bringing one guest. Jim will check with the school principle regarding having food at Sargent. When we have the count Geoff will check with L & L. The date will be the January meeting, the 23rd. The dinner will start approximately 45 minutes prior to the regular meeting.
- b. CBT (Citizen Benefit Fund): RCONA on February 1st gets a grant of \$2-3 thousand dollars. RCONA has now realized that individual neighborhood associations can piggy back on its application if the NA identifies a project, writes a grant proposal and gets it to RCONA by mid-January.
 - i. We can develop a request for as much as two thousand dollars. Shirley suggested painting the storage units over by the playground. These may be removed. She will check at the Community Center to see what is going on with these units.
 - ii. She also suggested applying for someway to enclose the recycling bins.
 - iii. Jim suggested having bins brought into the neighborhood for neighbors to dump large trash, couches, etc.
 - iv. If we were to do this for this year we'd have to prepare a proposal to go to RCONA by the first week in January. While we may proceed on this it was recognized this may simply be groundwork to apply in 2018.
- c. RCONA Scholarship Fund: RCONA will be providing two \$500 scholarships. These are given to students who have participated in two neighborhood events, NNO, Park cleanup, etc. The board is open to participating in the program. The question was asked if this is tied to the school year or the calendar. Jim will follow-up on this. (see attached)

9. Announcements and Remarks:

a. We discussed having guest speakers during the coming year. Jim will look into having the new police chief come to the January Meeting. This would then be announced in the December and January newsletters.

b. Jim noted that, according to the bylaws, board positions run according to the calendar year. Therefore officially David A. remains a board member through the end of the year.
