- 1. Meeting called to order at: 7:00 PM
- 2. Sign in/Welcome
- 3. Police Report:
 - a. Chief Mccoun Spoke first to the homeless situation and the inability to enforce the anticamping laws. The department went to a social service model and hired an individual to take on that role. Because of legal changes the police now have a blended model which allows enforcement as well as the social services approach. They also work with probation and have one probation officer for this area. Of the 250 homeless within the city 100 of these are on probation. So over all the situation is improving with the dual approach.
 - b. Drug offences no longer incur jail time only probation. The city has five probation officers in addition to the one handling the homeless.
 - c. The department has increased activity in working with the youth. There are a number of areas that are problematic for youth including: driver safety, substance abuse, sexting, etc.
 - d. Re. The Maidu Neighborhood specifically: Our neighborhood is in the best shape of any neighborhood with the exception of Del Webb Sun City. But there are still problems. The type of calls include: suspicious animals or people, alarms, car break-ins, etc. We only had 5 garage burglaries in all of 2017. Four were with doors left open. 5 reported door kick-ins with only 3 home entrances.
 - e. A question was asked regarding the City's position on handling guns being taken onto school campuses. There are police officers on every high school campus of which the city picks up 2/3rd of the cost and the school system picks up the other 1/3rd. One kid was caught last year bringing a gun onto campus using this system.

- f. The question came up about "campers" in the Lead Hill Wal-Mart parking lot. Apparently this is Wal-Mart's practice to encourage campers to stay in their lots with no time limit requirement. The Pleasant Grove site has a deal with the city not to allow this but this isn't the case on Lead Hill. The city is trying to make arrangements with them to stop.
- g. Officer Haley spoke. Most of the crime problems we experience are created by people coming in from Sacramento. He is our current beat officer.
- h. Officer Baquera spoke on the subject of Neighborhood Watch groups. He was encouraging everyone to have a traditional neighborhood watch. He also recommended people to get involved in setting up a virtual neighborhood watch on NextDoor. He also discussed video doorbells, etc, and registering them with the city as another way to increase home security. The city will be having a neighborhood watch meeting on Tuesday the 30th at 6:00 pm at the Roseville Police Dept., Mark White Room. The address is 1051 Junction.

- **5.** Treasurer's Report: The ending November balance was \$1,769.97. The ending January balance is \$1363.81
- 6. New Business:

 - b. Fire Station #4 will have an open house on Saturday, February 3rd from 9-11 AM. 1900 Eureka Rd.
 - c. Thoughts from Block Captains: The board requested suggestions to increase attendance at meetings. This led to a discussion regarding traffic control, Specifically related to Ridgecrest Way the Chief spoke to this. He talked about the rotating officers, speed signs and the limitations of using the Laser Guns under state law. The gun can't be used on residential streets;

Getting back to the original question it was suggested we get a museum representative to talk about activities, someone from Placer County SPCE. But what it really boiled down to is that the best attendance is when we have speakers addressing whatever are the hot topics of the moment.

- d. Movie in the park: Maidu will be hosting one movie but the date hasn't been set. We were asked which of a number of choices we liked. While attendees were pretty scattered on choices these are ones that floated to the top: Wonder, Despicable 3 and Finding Dory.
- e. Email Delivery: The issue arose because one neighbor didn't want to receive a hard copy because they're away so much. Nobody was particularly interested or concerned about receiving access to the newsletter this way. Geoff was concerned that we don't start a precedent of skipping houses because that will create problems for Block Captains. It was suggested this is a perfect example of how families are to watch out for one another. A neighbor can just pick up the newsletter if someone is away.
