

Back-to-School & Pedestrians

We are lucky enough to have two grammar schools in our neighborhood, a comfort for our youngest who go off to a school not far away, and a convenience for busy parents. Here is your annual reminder that school is back in session, so we need to be extra careful and patient when driving around Maidu Elementary and Sargeant Elementary Schools.

Did you know that according to the National Safe Routes to School program, more children are hit by cars near schools than at any other location? The following tips apply to all school zones:

- Don't double park; it blocks visibility for other children and vehicles.
- Don't load or unload children across the street from the school.
- Carpool to reduce the number of vehicles at the school.

And our awareness has to extend to anywhere a school bus travels. According to research by the National Safety Council, most of the children who lose their lives in bus-related incidents are 4-7 years old, and they're walking. They are hit by the bus, or by a motorist illegally passing a stopped bus.

Here are a few precautions to keep children and other pedestrians safe:

- Don't block the crosswalk when stopped at a red light or waiting to make a turn, forcing pedestrians to go around you. This could put them in the path of moving traffic.
- In a school zone stop and yield to pedestrians crossing the crosswalk or intersection.
- Never pass a vehicle stopped for pedestrians.
- Take extra care to look out for children in school zones.

Everybody knows what they should do, so these points are just reminders.

Neighbor Shares Story of Theft as a Reminder

Early this month a couple of neighbors who live near Maidu Park's east side experienced a jewelry theft that has by turns shocked and frustrated them. They decided to share their story as a caution to the rest of us.

They discovered they had been robbed after a week out of town. When they went to their front door on their return, they discovered it was already unlocked. They entered the house and found that their electricity was off. They discovered it had been turned off at the circuit breaker box and turned it back on. When they entered their master bedroom area they were shocked to discover a mess with items thrown around in the master bath and closet as well. At this point they noticed jewelry was missing. Later they found a pillow case or two were missing as well.

A neighbor had been watching the house for them, and had moved their garbage can from the street up to their gate. It became apparent that, after cutting the power to the house, the can had been used by the thieves to get a boost over the fence and into the backyard. Then they broke into the house through the back patio door. The neighbor had heard a bang at night about 4 days before they returned home and went to investigate, but didn't see any lights on or see anything wrong. Likely the thieves used flashlights to navigate the powerless home. When done with their sacking, they probably unlocked the front door and left.

The neighbors reported the theft to the police. When asked, the officer who took their report said that theft like this is not common to our area. As of the time of this writing the police have not uncovered any new information about what happened. The neighbors are monitoring sites online and will visit local pawn shops, but, as the officer suggested, the thieves may have sold the goods through another channel.

The neighbors are frustrated as they know they could have done more to prevent what happened. First, they did not do enough to make the home appear to have someone home. They had not, for example, set -up lights to go on at night. Second, they have an alarm system in their home, but between the two of them they each assumed the other had set the alarm. The alarm would have worked even with the power cut -off as it has a battery back-up.

Our own observation is that unlike the usual smash-and-grab approach that characterizes many thefts, this one apparently was thought out to the extent that the thieves observed the home was empty, cut the power, and focused on taking just small, valuable items that would allow a quick get-away. We're sorry to hear this happened to a neighbor because we know that jewelry often has specific, wonderful memories attached to it which makes the theft all the more painful. We thank our neighbors for sharing their story as a reminder to take steps to avoid becoming a victim ourselves.
