3. Police Report:

- a. Officer Gasaway is the officer for our beat. Beat 2.
- b. Number 1 crime is still theft, usually from local restaurants and movie theatres. But trhere are also significant numbers of transient related crimes and thefts in parking lots of Wal-Mart and Target.
- c. There have been significant Problems with juveniles fighting in city parks including Maidu. The officer recommend calling in if we see anything of concern.
