They also want to make changes to the skate track and want to talk to neighbors about this. They're putting in an exercise area near the library. There is to be an interpretive room tied to the new pump house.


- f. June Event: The date will be June 19<sup>th</sup> 10:00 AM. This is subject to availability. Jim will follow up availability.
