- 1. Meeting called to order at: 7:04 PM
- 2. Sign in/Welcome:
- **3.** Police Report: The Chief joined us to introduced himself to the group. He stopped in to say hello.
 - a. Flock Safety is the company providing the new license plate reader system. There are cameras mounted on light posts to check plates of vehicles coming into the city. The switch to Flock Safety is primarily because the camera equipment is better than that of the previous vendor and the service is more reasonably priced. Therefore, the department was able top purchase more cameras.

There are six cameras located in the 65 area, especially around the Galleria. Additional cameras are at: Riverside and Cirby, Cirby and Kensington, 80 and Douglas, both ends of Fiddyment and 2 cameras at Pleasant Grove and 65. The results have been phenomenal They have captured more stolen vehicles and ones with guns and drugs for sale, etc.

The department is looking next at Sierra College and Hazel areas for cameras.

The right to privacy is very carefully watched with oversight, and purging of the data. It is only used as an investigative tool.

He noted that neighborhood associations can get cameras for their area. The cost is \$2,500 per year on a lease basis with a \$250 installation cost.

- b. The Chief noted they are setting up the Real Time Crime Center which encompasses Flock and will integrate any other technological networks. This is intended to help officers get to a crime scene faster and has already been improving response time.
- c. Top five crimes are 1. Theft from vehicles and catalytic converters, primarily from Prius and Honda Accord. 2. Shoplifts from businesses. 3. Vandalized vehicles 4. Vehicle theft 22% from auto dealers and 22% from parking lots 5. Non-vehicle related. These are generally non-violent crimes.

4. Minutes of November Meeting:

Melinda and Mary H discussed the need for donations from businesses and them advertising. Mary H asked for a general letter (which would include our Tax Payer #).


Alan will put together a letter. She will follow up to see what some of the vendors need. Geoff will update the one we've been using.

- f. BMX Location: The city is considering putting in one and is looking for suggestions as to location. An alternative, if not in Maidu, would be on Excelsior but the high tension lines might be an issue. The real question is, would any location be fenced in and the assumption is, yes.
- 8. New Business:
 - a. COVID Vaccine and Physical Board Meeting: Scott suggested a hybrid meeting: In person/Zoom. Alan is going to try to get the city to comp us and let us use the Maidu Community Center. He'll also check on the availability of the Interpretative Center. Tentatively we will plan on aiming June for in person/Zoom meeting.
 - b. City in person services: The city resumed services yesterday.

 - a. Lance noted there are Redwood trees which are dying along Mclaren and Rocky Ridge. Alan will touch bases with the city.
