- 2. Sign in/Welcome:
- **3.** Police Report:
 - a. Burglary is one of the top crimes. These are in both commercial and residential areas. Much of it is from cars. 38% is from activity in the commercial, 35% represents catalytic Converter thefts and the balance, 17%, is city-wide. Over all Burglary is split evenly between commercial and residential areas.
 - b. Vandalism is up 17%. Trespassing occurrences are only in businesses when someone is asked to leave.
 - c. Homeless issues continue to be a problem. There was a 40% increase, in tons, of garbage from homeless camps.
 - d. FLOCK Live: The camera system is proving effective. There have been 29 calls for service 11 contacts arrests and 19 people arrested. 93% have been individuals from outside city driving stolen cars Right now the area that is benefiting the most is Douglas at 80, with 48% of contacts. More cameras will/are being added at Atlantic.
 - e. Within the city Harding is a problematical location, including the homeless. An officer was fired on here.
 - f. Traffic concerns. Concerns were expressed that accidents, due to speed, are more serious. Street racing seems to be less of a problem because of chatter saying "stay away from Roseville."
