Staying Safe While Selling

If you think you can safely hold a garage sale, this year's Garage Sale Packets will include a reprint of our article from last month's newsletter on the guidelines the Placer County Health Department and California Department of Food and Agriculture offer for Farmers Markets. 
Potential New Development Alert from a Neighbor

Hello Neighbors, the City of Roseville is proposing a General Plan Amendment and Rezone from open space to residential, and floodway to residential. This notice is posted at Samoa Way and North Cirby Way.

We called the number on the sign to inquire as to why we hadn't been notified as we live a stones throw away and had always been notified of such action in the past. We were told as of now they only notify residents residing within 300 feet of the proposed building site. We then asked to be put on the mailing list to be notified of any further action at this site.

We are suggesting that all of our neighbors that are interested in this property make this call to be notified.



Virtual Neighborhood Meeting August 11 on Samoa Infill Development

On Tuesday, August 11th, the City of Roseville's Planning Division will hold a virtual, online neighborhood meeting regarding the rezoning of three lots at the intersection of North Cirby Way and Samoa Way. One lot is at the corner of the two streets, and the other two lots are adjacent to it along Samoa Way. The rezoning request would take the lots from FW (Floodway) to R1 (residential) zoning.

After this meeting, the City's Planning Commission and then, later, the City Council will review the request. The timing of either review is not defined at this point.

The accompanying picture shows the location

Some neighbors are concerned about developing the natural space. Others assert the property owner's right to develop the land. Some recall the regular flooding in the area which was the reason it was designated floodway zoning, but over the last couple of decades the City has taken steps to widen the water way and enlarge the conduits under downstream bridges. If these properties fall outside the new 100-year flood mapping for the area, then they may be rezoned as no longer being a floodway. As AC Steelman wrote in the article above, contact the City at the phone number on the sign (see picture at top) and leave your contact information if you have an interest in this project.

The MNA Board will meet online this month on Tuesday, August 25th. The Board's attempts to meet at Maidu Park the last two months has been cancelled each time because of excessive heat, so that will not be attempted again until the September meeting.

Placer County Has Our Stats

Would the accurate number of COVID-19 cases in Placer County, without commentary, be of interest to you? Would knowing how many cases have been detected within your zip code help you assess your risks? If so, the Placer County COVID-19 Dashboard will be of interest to you. It provides daily updates on the latest local data including:

- New cases
- Cumulative number of cases since March
- Number of people likely recovered
- Deaths
- Current cases in Placer County hospitals
- Current number of ICU patients
- Available ICU beds

The Dashboard shows, as of August 2, there have unfortunately been 16 COVID-19 related deaths in Placer County, of which 13 have been among residents over 65. The Dashboard also reports, as of the same date, nearly three out of four of the 17 ICU patients in Placer were not Placer residents. This is largely because the open ICU beds in our county have let Placer take overflow cases from neighboring county's hospitals already at capacity.

<u>On Our Radar</u>

• **2020 Board Candidates Nearly Final**—The Association will hold its annual election of board members at the September Annual Meeting. Any one who is a neighbor can vote at the Annual Meeting for the Board. About half of the board positions are up for election each year with board members usually serving a two-year term. We welcome anyone who would like to be a candidate and help serve our neighborhood. Please note our bylaws dictate that all candidates must be declared a month in advance of the election. This year that deadline is Saturday, August 22nd.

So far, the announced candidates are existing board members who agreed to run for another term. They are Alan Bartley, Melinda Shrader, Mary Steele and Scott Reid. There is one board position open. - Community Center Remains Closed, Library Still Doing Sidewalk Pick-up—The library's front sidewalk pick-up hours are Tuesday-Saturday, 10 a.m.-4 p.m. Borrow online, then go to pick-up.
