1. Meeting called to order at: 7:05 PM

2. Sign in/Welcome:

3. Police Report:

- a. Flock Camera stats:
 - i. The department pre-loads the license plates suspected of being involved in crimes in the region. This year the Flock Cameras allowed RPD to contact 77 of those vehicles in Roseville.
 - ii. Last week the City Council approved 10 more of the cameras for purchase and/or placement in theCity. Two of those cameras will be purchased by the Galleria for placement in their vicinity. These10 additional cameras will double the number in Roseville.
 - iii. 96% of stolen vehicles spotted by the cameras in Roseville come from outside the City.

b. Other crime stats:

- i. In 2020, from January through October, there were 204 catalytic converter thefts reported in Roseville. In 2021 for the same period (through the meeting date on 10/26) there were 329.
- ii. 45% of East side beat crimes are related to commercial establishments.
- iii. 33% of thefts are done between midnight and 5 a.m.
- iv. There were 22 rapes in Roseville in 2020. Most are through some existing relationship between the parties, not random perpetrators.

- **4.** PRL Ambassador Program & other Parks news:
 - a. PRL Ambassador Program is starting.
 - i. PRL wants volunteers who will have eyes on our parks. They should be friendly and outgoing.
 - ii. Main job is to welcome and educate people about park use. This is not an enforcement role.
 - iii. They might also have a role in checking in on rentals, but Maidu Regional Park doesn't have any of those.
 - iv. Observations of problems or needs can be reported by the volunteer via a phone app.
 - v. PRL is flexible as to the hours people volunteer.
 - vi. Maidu is a place for a team of ambassadors.
 - vii. Ambassadors will receive training on how to do the job and stay safe.
 - viii. There is a page at the web site to sign-up.
 - ix. Others not in this program can always report issues in the parks to 916-772-PLAY.
 - b. New Fitness Court is almost finished.
 - i. On Nov. 6th, 10 a.m., there will be a demo on how to use it.
 - ii. PRL department is still looking at what improvements to do to the skateboard area and will consult with the folks using it for ideas.
 - c. For BMX course, they are still looking at a non-environmentally impacting area behind the soccer fields.
 - i. Lockridge Park location could be BMX, but the concern is still the high tension lines that run overhead. That park might be better suited to being a fenced dog park.
- **5.** Minutes of September meeting:

6. Treasurer's Report: The ending September balance was \$4,235.65. The October balance as of this date is \$3,737.23

7. RCONA:

- a. There will be neighborhood dumpsters, financed by \$50,000 from the City. RCONA will identify where they are to be placed. This will likely roll-out in the spring. The program will not be generally advertised. (When they advertised it being done in a neighborhood, people were coming from all over to line up and dump things including commercial land-scapers seeking to avoid dump fees.)
- b. We can have up to 10 signs put up in our neighborhood to welcome people to the Maidu Neighborhood with a logo of our choice with the City approving the locations and paying for the signs.
- c. On November 1st the City will post the routes for Neighborhood Santa in December.

- d. The Gathering Inn wants to move to Sunset Industrial area where they could house more people in a better facility. They are willing to meet with Neighborhood Associations to get their support for the move. Jim will be coordinating such a meeting for 4associations, including our own, to be held at the Maidu Community Center.
- e. Redistricting Submit your feedback via the City web site by December 6th.

8. Old Business:

- a. Block Captain Dinner Alan suggested having a barbeque at the Park to cut costs. He would be willing to cook.
- b. Budget We reviewed the budget projections Alan put together which show that by the end of 2022 we would be low or out of money if we do the same activities at the same expense as we did this year. Jim pointed out that we've always had a reserve of money to print the newsletter should our sponsor leave us for any reason. (see attached)

9. New Business:

- a. Flock Cameras Alan proposed to raise money though a Go Fund Me page to get 4 Flock Cameras for our neighborhood. We'd need to raise about \$6,000. He said he's had people ask him how they could contribute to the Association, so he's optimistic that we could raise the money. Alan agreed to get more information about setting up a Go Fund Me campaign
