

Maidu Neighborhood Association
Monthly Meeting Minutes
June 2023

- Date of Meeting: June 27, 2023
- Time of Meeting: Meeting called to order by Alan Bartley at 6:33 p.m. at the Maidu Community Center.
- Attendance: Officer/Board Members present (who signed the sign-in sheet): Alan Bartley, Mary Hoff, Jim Kidd, Scott Reid, Shirley Brown; Acting Board Member: Lance Hibben; Neighbors: Susie Williams, and Don Struckmann.
- Roseville
Police report: Police Sargent Hagerman and Officers Maldonado and Ritter were present to discuss concerns and questions regarding upcoming fireworks for the July 4th holiday. False reports of gun shots are typical and Police have limited resources to respond to related complaints which may be a low priority depending on other simultaneous matters requiring their attention. A neighbor questioned the effectiveness of steering wheel locks as a method to discourage or prevent auto thefts and asked if there are areas in Roseville more prone to automobile thefts. Officers responded the locks are helpful but they were not aware of any specific area more problematic than other areas. They did mention the Roseville FLOK camera system identified a stolen vehicle that they located in a nearby shopping parking lot. When they were there, the suspect came out of a store with stolen merchandise and was arrested.
- Guest Speaker: No guest speaker this month.
- Visitor Forum: Lance Hibben presented an idea tentatively called “Maidu Cares” with a hand-out with discussion points. Basically, the idea is to create a list of neighbor volunteers who are willing and able to help other neighbors in need of help with front yard landscaping issues. Discussion included clarification, issues, and opportunities. The concept received encouraging feedback with requests for more information, a future newsletter article, and more discussion as an agenda item for a future MNA Board meeting.
- Minutes from prior meeting: Minutes were approved from the May meeting.

Treasurer's
Report:

No report available at meeting. A spreadsheet was provided in advance of the meeting showing \$3,783.01 in the MNA account.

RCONA report:

Jim Kidd reported the following RCONA topics:

- Roseville fireworks sales and legal timeframe for use.
- City's 4th of July parade and fireworks show at The Grounds.
- City property owner weed abatement. If city cleans-up a property, they will send an invoice to the property owner to pay for associated services.
- RCONA scholarship updates and participation eligibility requirement.
- RCONA has \$36,000 and is encouraging neighborhood associations to provide proposals for using funds. These funds have been raised from past fireworks sales revenues, donations, and \$1,500/year from the city.
- Jim submitted a request to RCONA for annual \$100 (to help pay for our pancake breakfast).
- City bus services overview and requests for feedback.

Old Business:

National Night Out (NNO): Scheduled for Tuesday, August 1st at Maidu Park. MNA plans to host an ice cream social. Alan needs help planning and preparing for the event due to other commitments. He will provide a list how people can help. Like previous years, the plan is to use Leatherbys to provide ice cream and cookies.

Pancake breakfast review/feedback: Police did not attend as they did not receive correct notice. There is a form that needs to be submitted in advance to ensure police participation at future events.

Discussion about vacant board positions. There was a discussion about MNA hosting a recognition dinner for Block Captains in September as a way to encourage possible candidates to fill vacant board positions. Another newsletter article was discussed.

New Business:

Annual Maidu Park clean-up and lunch scheduled for October 14th. Discussed improvement idea from prior year using a scale as a method to quantify trash collected for comparing

year-to-year. Alan indicated he has a hanging weight scale.
