## Maidu Neighborhood Association Monthly Meeting Minutes May 2023

Roseville

Police report: Police Sargent Hagerman and Officer Foppiano were present to

provide a monthly update and address questions and concerns. Maidu is considered to be a quiet and safe neighborhood. The main issues are speeding and automotive catalytic converter thefts. Attendees brought up a few topics for discussion including "side shows" involving reckless driving and police involvement with school safety. Sargent Hagerman explained the best way to respond to speeding or other traffic concerns is to report them on the Police Department's feedback page on their website. Regarding school safety, Roseville Police Department provides School Resource Officers for each campus of the Roseville Joint High School District; active shooter response training; and a proactive "Threat

Assessment" detective involved with analysis of people who come to their attention in order to take appropriate actions in advance of potential incidents. School safety was the featured topic of monthly guest speaker, Roseville City School District

Superintendent, Derk Garcia.

Guest Speaker: Derk Garcia, Superintendent Roseville City School District

(RCSD). Mr. Garcia (Derk) has been the Superintendent for nine years and formerly with San Juan Unified School District. RCSD plans to open its 21<sup>st</sup> campus providing education to 21,000 students in grades P-8 including Sargeant Elementary

School within the Maidu neighborhood boundaries

Demographics are shifting from east Roseville towards west Roseville creating challenges for school operations. RCSD hired a consultant five years ago to evaluate and prioritize campus security improvements. Derk described procedures and improvements that have been implemented; what they are currently working on; and future improvements subject to funding availability. He indicated there are some improvements not for public knowledge. Derk emphasized the district's focus is to address mental health issues such as preventing bullying behaviors. Over the past nine years, the district has increased the number of counselors on school campuses and encourages parents to limit and supervise children using social media. RCSD does not plan to implement metal detectors or police school resource officers (due to cost).

Visitor Forum: There was no visitor topics presented not already covered on

the meeting agenda.

Treasurer's

RCONA report: Jim Kidd reported the following topics:

Feedback from the RCONA/City Dumpster Day held at Maidu Park on Saturday, May 20<sup>th</sup>. 20 bins filled and about 320 cars came through (record setting volume). Some people waited and hour and a half in line. RCONA is reviewing this year's combined events for improvement ideas for next year. The last Dumpster Day for 2023 is planned on June 10<sup>th</sup>.

RCONA provided an advisement concerning solicitors asking for donations and city pre-approval requirements for business solicitors.

RCONA wants to better educate city residents about the organization and is asking neighborhood associations for help publicizing events via watchmail.

**Old Business:** 

Pancake breakfast initial budget was set at \$200 and task assignments were made.

It was approved to allow South Cirby Neighborhood Association to share storage space with MNA at the U-Haul storage facility (donated by U-Haul). Need to decide on a summer meeting location (beginning in June). Alan will secure a meeting location. A motion was approved to pay \$35 in the event we meet at the Maidu Community Center.

New Business: Initial planning for National Night Out was discussed.
