Don Struckmann has decided to retire from the Board.


At our November 28th meeting, officers were appointed by the board as follows:

Local Bike and Walking Trail Construction begins

In 2008 the initial planning was started for a mixed-use trail on our side of I-80. The City has funding for the first half of the trail going from near Riverside Avenue north of Cirby Way, under I-80, and all the way to Rocky Ridge Drive. The trail, as you may see in this graphic, follows Linda Creek, switching occasionally from one side of the Creek to the other via bridges.



Upon its completion, we will be able to bike and walk from the far side of Rocky Ridge all the way to downtown and beyond without being on streets. Phase 2 will complete the trail through our neighborhood.

How will Sites Resevoir Project Help Roseville's Water Supply?

You may have heard that that Sites Reservoir project has the green light for construction. It will be an above-ground water storage facility in Glenn and Colusa counties, west of I-5. So how will water captured there help our water system here which primarily receives water from Folsom Lake?

The Sites Reservoir's location offers a potential solution for storing excess surface water across California, aiming to reduce dependence on existing water storage facilities like Folsom Lake. Specifically, it will be a substantial water source that can be channeled into the Sacramento-San Joaquin Delta.

That, in turn, will alleviate pressure on Folsom Lake as less water needs to be released into the Delta for environmental preservation. In short, there should be more water available to Roseville and the other local cities that use it as their primary water source.

The City of Roseville already has a seat at the table so to speak. In 2017 it decided to join the project and shares a board seat on the Sites Joint Powers Authority Board with the Placer County Water Agency, allowing it to influence the project and its outcomes.

Scams Come in the Door-to-Door Variety Too

No doubt you are aware that there are many online scams these days. And if you have a working phone, you know that fishy calls can come almost any time. We'd just like to remind you that less-than-honest folks can walk up to your door too.

It's relatively easy for scammers to go door to door pretending to be collecting for a charity. Some even have fake IDs they show you, knowing that you don't easily have the capability to check if the ID is

valid or not. To help deter door-to-door scammers, post a "No Soliciting" sign on or near your front door. If you need such a sign, follow the QR code at the bottom of this page where we provide a link to a Roseville Police Department version you may print (shown at right).

If you are out around town and someone is collecting on the sidewalk, don't assume they are a legitimate charity. Check them out on your own before giving money or your personal information.

Tips to follow for any charitable giving:

- Don't let any charity rush or pressure you into making a donation of any kind.
- Look for specifics regarding how your donation will be used.
- Confirm that the charity or organization is legitimate.
