[Editor's Note: You may have seen the new "Story Walk" along the Maidu trail in the natural area. Many people like it, but others do not. Here is one neighbor's take.]

In November I was walking on the interior nature trail at Maidu Park when I came upon 22 poles installed along the trail with a signboard attached to each pole showing a children's story. I was quite shocked to see these as I frequently use this path to decompress and enjoy nature. The story boards were jarring to my experience. I later discovered they were installed by the City Parks, Recreation, and Libraries Department with funding provided by Friends of the Library.

If you've seen them, then you know they contain a charming children's story. I have no issue with them per se. My concern is when I am in nature, I want to see oak trees, California poppies, birds, etc. I don't want to see man-made structures. There is enough development in this area with all the exercise equipment and memorial benches that have cropped up.

I would like to see this trail free from development. The story walk is too much. My firm belief is that story walk needs to be placed where children are; for example, by the big



Proposed Apartment Building Raises Concerns About Traffic

The MNA November meeting included guest speakers Sara Lebastchi with D and S Development and the following City of Roseville representatives: Escarlet Mar, Associate Planner, Marc Stout, City Engineer, and Matt Todd, Traffic Engineer. The developer and City representatives attended the meeting to collectively present a proposed infill development of an 18-unit apartment complex at 1995



development of an 18-unit apartment complex at 1995 Rocky Ridge Drive (at the corner of Rocky Ridge Drive and South Cirby Way).

The developer and city staff presented an overview of the project and spent most of their time answering questions and addressing concerns from attendees. The project is on a 1.23-acre Medium Density Residential parcel with units ranging from one to two bedrooms. Two units will be considered affordable while the remaining 16 units will be available at market rate. A total of 27 parking spaces will be provided on-site. The project includes a Tree Permit (TP) to authorize the removal of 42 protected oak trees from the project site. Currently the project is creating Environmental Impact Report (EIR) documents and preparing to be presented to the City of Roseville Planning Commission (tentatively in February 2025). This is the second time the owner/developer has proposed development of this site. The first proposal failed to move forward due to poor economic conditions during 2007-2010. The current proposal included noticeable improvements to the architectural elevations.

Attendee questions and concerns were almost entirely

focused of traffic and safety concerns generated by the project and the parking lot within the project site itself. Attendees were focused on roadway designs, entering/exiting the project's parking lot, the number of parking spaces, and the absence of visitor parking. In addition, concerns were expressed about the safety for Oakmont High School students, pedestrians, and residents living in duplex units across South Cirby and residents on Condor Court navigating the intersection of Rocky Ridge Drive and South Cirby Way.

Attendees' concerns increased when told by city staff the level of planned roadway improvements were minor. City staff explained the current roadway design based on the City's 2020 Base Travel Demand Model was adequate for mitigating the increased small amount of traffic generated by the project. But the model does not account for nearby projects built and planned by Placer County on Old Auburn Road in 2024. Residents at these new Placer County projects will also use South Cirby Way including this intersection.

There are no flood plain issues from Linda Creek affecting the proposed project. Neighbors who still want to express concerns should attend a future MNA monthly meeting, contact a MNA Board member, and/or write letters to city representatives. The MNA Facebook page has been updated to provide a link to the City's website which provides more project details.
