Date of Meeting: March 25, 2025

Visitor Forum: There was a concern (relayed by Vicki Miller by a neighbor not in attendance) about the goats in the park. The concern was based on goats destroying vegetation in the park without clear demonstrated benefits. Because the concern was not elaborated, no significant discussion ensued.

Minutes from
prior meeting:

Meeting minutes from the February meeting were approved. On a separate but related topic, Lance Hibben proposed adding subjects to the left margin of the meeting minutes related to annual activities such as the annual election of MNA Board members and annual MNA audit. The intent was to include these topics to serve as an ongoing reminder of these annual activities. The Board felt these reminders were not needed.

Treasurer's
Report:

Shirey Brown reported \$4,107.61 as the current account balance. She added some garage sale receipts have been received.

RCONA report:

Jim Kidd reported the following topics related to RCONA activities:

- An RCONA internal grant is still available for up to \$2,000. The funds are for neighborhood improvements. Jim will resubmit the rules for the grant. As of this date, no neighborhood association has applied for the funds. The deadline to submit grant requests is March 31st.
- The RCONA annual Spring Clean-Up still seeks additional volunteers. Volunteers can sign-up via Sign-Up Genius. There are three shifts each clean-up date.

Old Business:

The MNA plans to have 9 or 10 people attend at our table during the RCONA Sweet Celebration event in April. The MNA plans to honor Melinda Shrader and the Rocky Ridge Town Center Sprouts Farmer Market Manager for their service and support to our neighborhood. Lance Hibben and Shirley Brown will provide brief bios for each honoree, respectively by March 31st for the presentation of awards at the event. Jim will send an event advertising poster to social media inviting neighbors to attend. As of the current date, nine Roseville neighborhood associations have purchased tables for the event. RCONA's budget for the event was set at \$4,000.

The May 3rd annual garage sale planning was discussed with tasks assignments and updates. The budget was set last month for \$550. This included the purchase of portable helium tanks,

advertising, and the new reusable banner (which was delivered and given to Jim Kidd). Jim will work with Maidu Park staff to have the banner displayed before the event.

New Business: Lance Hibben provided an update regarding activities of the small committee formed to address the proposed 18-unit apartment complex at the corner of Rocky Ridge and South Cirby. A draft document is planned to be sent to the MNA Board for review in April.
